PROGRAM DETAILS

- Coachella Water Authority and Sanitary District offers a rebate of up to \$150 when you upgrade your old toilet using 3.5 gallons per flush (GPF) or higher to a new, high-efficiency WaterSense model.
- One rebate per single-family residence or multi-family dwelling unit.
- New construction and replacement of toilets installed after 1993 do not qualify.
- Toilet installation must be within the CWASD service area and served by an open and active potable water service account.
- Rebate will cover the cost of the toilet, up to a maximum of \$150.
- Replacement toilet must meet EPA WaterSense standards.
- Application must be postmarked within 90 days of purchase.
- A separate application must be submitted for each metered address.

The undersigned expressly agrees that COACHELLA WATER AUTHORITY & SANITARY DISTRICT (CWASD) may inspect all properties participating in the Toilet Replacement Rebate Program; that CWASD does not guarantee the performance of any toilet; and that CWASD does not warrant any toilet or installation to be free of defects; the quality of workmanship, or the suitability of the premises or the toilet for the installation. The undersigned further agrees to defend, indemnify and hold harmless CWASD, its directors, officers, agents, and employees, from and against any and all loss, damage, expense, claims suits and liability, including attorney fees arising out of or in any way connected with the toilet and its installation. Applicant has read, understands and agrees to the terms and conditions listed on the High-Efficiency Toilet Rebate Program application. Applicant understands that installation of a qualifying low flow toilet may not result in lower water bills. CWASD reserves the right to change the terms of the incentive offer at any time.
